ENTRY / SIGN - IN	<p>Entry not required to be sent, <b>Direct sign-in at the venue on Saturday 12<sup>TH</sup> JANUARY – 19 between 9:00 am to 10:00 am. Draws will be made immediately &amp; Matches will start from 12TH JAN (Sat) at 11.00 am.</b></p> <p><b>Entries will not be accepted through mob / telephone / e-mail. It is mandatory to come and sign – in at the venue i.e. BEL OFFICERS CLUB. KSLTA / The organisers will in no way be responsible for the sign in taken by private agency. Entry of correct AITA no is the responsibility of the player participating.</b></p>
MATCH FORMAT	<p>As per AITA rules - The tournament will have an OPEN DRAW WITH NO QUALIFYING ROUNDS.</p> <p><b>TILL QUARTER FINALS ALL MATCHES WILL BE BEST OF 15 GAMES (DEPENDING UPON THE SIZE OF DRAW). IN CASE 7 – 7 NORMAL TIE-BREAKER WILL DECIDE THE WINNER.</b></p> <p><b>IN CASE OF SEMI-FINALS &amp; FINALS THE MATCHES WILL BE BEST OF THREE SHORT TIE-BREAKER SETS( 4 GAMES TO WIN WITH DIFFERENCE OF 2 AND TIE-BREAKER AT 3-3) WITH NO –AD SCORING SYSTEM( 1 POINT AFTER DEUCE DECIDES THE GAME)</b></p> <p><b><i>There will be No seeding in the draw till the next change of rules</i></b></p>
AGE ELIGIBILITY	<b>The player must be aged between 7 –10 (i.e. completed the age of 7 on the day of competition till the age of 10 in the calendar year).</b>
ENTRY FEE	<p>All players must show their valid AITA / ITN Registration card and pay the entry fees before playing their first match.</p> <p>Singles: Rs.350/- per player. No Doubles event.</p>
AITA Registration Card	<b>It is mandatory for the player to carry ORIGINAL REGISTRATION CARD for the sign-in. In case the player registration is in process with AITA, In that case player has to carry Original receipt or copy of mail from AITA confirming that player registration is in process.</b>
ENTRY IN THE SIGN – IN SHEET	<b>ALL PLAYERS ARE REQUESTED TO MENTION THEIR STATE, DATE OF BIRTH, AITA / ITN REGISTRATION NUMBER AND THE CONTACT NUMBER IN THE SIGN-IN SHEET</b>
